Registration

- All hackers must register **in advance**. Participation without prior registration cannot be guaranteed.

Data protection

- Hackers agree to the processing of personal data.
- Hackers agree that their first name, last name and company/institute/university will be passed on to our cooperation partners.
- Two challenges are being organised as part of the Interreg project HACK-IT-NET (these are marked accordingly in the challenges). This means that the following conditions must be agreed to:
 1. the use of the event results within the framework of the HACK-IT-NET project,
 2. the transfer of a list of participants (including title, first name, surname, institution) to the Interreg project HACK-IT-NET
 3. the storage and processing of this data within the framework of the project
 4. Possible inclusion of this information in the final report of the project and other related publications.

Requirements

- Hackers of all countries, genders and religions are welcome.
- There is no age limit for the hackathon.
- In the case of underage hackers attending, a written declaration of consent from a parent or legal guardian is required to participate in the hackathon.
- Jury members are excluded from participating in the hackathon. However, they may assist participating teams in the programming and development phase.
- There are no country restrictions on participation, but taxes on possible winnings may occur, which must be paid by the hackers themselves.

Team

- Ideally, a team should be made up of designers, developers and people with medical or health-specific expertise. However, this is not a mandatory requirement for participation in the hackathon.
- Participation in the hackathon is on a "one team" basis, i.e. hackers can only participate in **one** team and cannot be members of multiple teams.
- If necessary for the successful completion of the challenge, we reserve the right to expand or reduce the teams before the hackathon begins.

Challenges

- All hackers work on **one** challenge during the Healthcare Hackathon Bayern.
- The hackers will select their challenge favorites. Whenever possible, they will work on their first choice. If this is not possible, the hackers will work on their 2nd or 3rd choice.

Project Development

- All software development programs such as IDE, programming languages etc. can be used. Cloud services are permitted for processing non-personal data as long as the data does not leave the European Union.
- To ensure a level playing field for all hackers, it must be disclosed to the jury which part of the code has been developed locally and which part has already been worked on in advance. The use of open source frameworks and existing projects is permitted and desired.
- The results of the project must be made available to the coaches and the jury or uploaded to the results server.

Prize money and prizes in kind

Regarding the prize money or non-cash prizes distributed by the project partner Medical Valley at the Healthcare Hackathon Bayern, legal action is excluded. The organizers and the jury reserve the right to adjust prizes at short notice or to reconfigure non-cash prizes.

Travel expenses / Travel expense reimbursement

- Travel expenses will not be reimbursed at the Healthcare Hackathon.

Intellectual property / use of the results

- All rights to the use of the work results of the challenges are held equally by the challenge provider and the hacker team. Neither the challenge provider nor the hackers may transfer or exploit the rights of use without the consent of the other.
- The rights to the use of the results that have already been produced in the preliminary stages to the hackathon belong to the person who produced them.
- All agreements that deviate from this general regulation must be concluded directly between the team and the challenge provider.

Code of conduct for participants

Our hackathon is free from discrimination and harassment of any kind, regarding origin, religion, age, gender, sexual orientation, disabilities, size, etc. We have zero tolerance for discrimination against participants in any form. Suggestive language is not appropriate during the hackathon, neither during the hacks, workshops, teamwork, parties or in social networks. Participants who violate this code of conduct may be excluded from the competition by the event organizers.

Discrimination and harassment, for example through verbal comments on gender, gender identification, age, sexual orientation, disabilities, physical appearance, body size, religious affiliation, origin or through threats, stalking, photography or filming without the consent of the person concerned, inappropriate behavior towards others, inappropriate physical contact, are not permitted at the event. If you have the person's consent or there are no people in the photos, photography is of course permitted.

We expect all participants to adhere to this code of conduct throughout the event. Participants who violate these rules may be excluded from further participation. The hacks created are also subject to the anti-discrimination policy.

If you are discriminated against or harassed or become aware of this, please report it immediately to the hackathon organizers.

The hackathon organizing team is happy to help participants in situations of discrimination and harassment to ensure a harassment-free event. We appreciate your participation!
